VISA VALIDITY

90 days

The visa has to be used within 90 days of its issue date

2 What the visa allows

✓ You are permitted to

- ✓ Reside in Indonesia for the full term of your permit.
- ✓ Enter and leave the country as often as you wish, with no limit on trips.

✗ You are not permitted to

- ✗ Remain in Indonesia once your visa has expired.
- ✗ Sell goods or supply services.
- ✗ Draw a salary, fee or any comparable payment from an Indonesian person or company.

3 General requirements

- A passport with at least **6 (six) months** of remaining validity.
- One recent colour photograph.
- A personal bank statement showing a balance of at least the equivalent of **USD \$2,000**. It must cover the previous 3 months and display your name, the date and the account balance.
- The sponsoring husband's or wife's valid visa, Limited Stay Permit (ITAS) or Permanent Stay Permit (ITAP).
- ITK / Permit Number *(when the application is filed from inside Indonesia)*.

4 Documents by applicant type

E31B Spouse KITAS

- Marriage certificate translated into Indonesian by a sworn translator.
- The husband's or wife's valid Limited Stay Permit, Permanent Stay Permit or Limited Stay Visa.

E31E Child KITAS

- Marriage certificate translated into Indonesian by a sworn translator.
- Birth certificate translated into Indonesian by a sworn translator.
- The parents' valid Limited Stay Permit, Permanent Stay Permit or Limited Stay Visa.

E31H Parent KITAS

- Birth certificate translated into Indonesian by a sworn translator.
- The child's valid Limited Stay Permit, Permanent Stay Permit or Limited Stay Visa.

WHEN TO APPLY

1 month before your KITAS expires

Documents & conditions

- A passport with at least **18 (eighteen) months** of remaining validity.
- A personal bank statement showing a balance of at least the equivalent of **USD \$2,000**, covering the previous 3 months and showing your name, the date and the account balance.
- The applicant has to be **physically present in Indonesia** for the renewal to be processed.
- The renewal must be started **within 1 month** before the current KITAS expires.
